## **PLACE WHERE DATA IS PROCESSED**

The processing operations related to the web-based services that are made available via this website are exclusively carried out at the aforementioned corporate headquarters by technical staff in charge of said processing or by other persons entrusted with such updating and maintenance activities as may be necessary from time to time.

No data resulting from web-based services is either communicated or disseminated.

Any personal data that is provided by users requesting information or services is only used to provide the service and/or to discharge the tasks requested and is disclosed to third parties only if this is necessary for said purposes. In such cases, limited to services and information requested, the data may be disclosed to the company’s employees, professionals, persons in charge, accounting, financial, tax and IT consultants of the company, financial and bank institutions, as well as to those persons in charge of defending the company’s interests in any administrative, judicial and extra-judicial proceedings as well as recovering corporate debts and those responsible for sending documents and auditing.

## **CATEGORIES OF PROCESSED DATA**

### *Navigation data*

The information systems and software procedures that enable the operation of this website acquire personal data as part of their standard functioning; the transmission of such data is an inherent feature of Internet communication protocols.

Such information is not collected in order to relate it to identified data subjects, however it might after being processed and matched with data held by third parties, allow for identification of the user.

This category of data includes IP addresses and/or the domain names of the computers used by any user connecting with this website, the URI (Uniform Resource Identifier) addresses of the requested resources, the time of such requests, the method used for submitting a given request to the server, size of file returned, a numerical code relating to server response status (successfully performed, error, etc.), and other parameters related to the user's operating system and computer environment.

This data is only used to extract anonymous statistical information on website use as well as to check its functioning.

The data might be used to establish liability in case computer crimes are committed against the website.

#### *Data Provided Voluntarily by Users*

Sending e-mail messages to the addresses mentioned on this website, which is done on an optional, explicit, and voluntary basis, entails acquisition of the sender's address which is necessary in order to reply to any request, as well as of any such additional personal data as is contained in the message(s).

#### **OPTIONAL DATA PROVISION**

Subject to the specifications made with regard to navigation data, users are free to provide personal data either to be entered in the application forms submitted in contacting the Office to request delivery of information or services.

Failure to provide such data may result in the impossibility of meeting the request.

#### **DATA PROCESSING ARRANGEMENTS**

Personal data is processed by printed and electronic tools, for no longer than the time strictly necessary to achieve the purpose for which they have been collected in compliance with the applicable laws in force.

Personal data will be processed in compliance with the principles of correctness, transparency and legality.

#### **PURPOSE OF DATA PROCESSING**

Personal data will be processed for the following purposes:

- a) any fulfilment resulting from the provision of the company's services, from any accounting, statutory, tax and public safety provisions, from administrative management of the relationship as well as any other fulfilment which is connected in whatsoever manner to the company business;
- b) for sending promotional material and information concerning the services provided by the company or any of its affiliates and controlled companies.

#### **DATA SUBJECTS' RIGHTS**

Data subjects are entitled at any time to obtain confirmation of the existence of personal data concerning them and be informed of their contents and origin, verify their accuracy, or else request that such data be supplemented, updated or rectified (Section 7 of Legislative Decree no. 196/2003).

The above Section also provides for the right to request erasure, to make anonymous or to block any data that is processed in breach of the law as well as to object in any case, on legitimate grounds, to processing of the data.
